The following personnel are authorized by the Commander, Florida Wing, to conduct flight checks as FLWG Chief Check Pilots IAW CAPR 60-1 to assist in the implementation of the check pilot program. This authorization becomes invalid with expiration of the pilot's FAA Flight Instructor Certificate, failure to maintain at least a Third Class Medical Certificate, expiration of the Form 5 flight check as a Chief Check Pilot or failure to comply with the requirements of the National Check Pilot Standardization Course. Group Chief Check Pilots are indicated under FLWG Group and are responsible for reporting to FLWG DOV. Only these Chief Check Pilots may give Check Pilot and Instructor flight checks. Check Pilots noted with an asterisk (*) are authorized by the Wing Commander to administer Chief Check Pilot flight checks. Flight checks may be conducted in all aircraft groups for which authorized under the Check Pilot personnel authorization. The number in the "Expires" column is the month and year of National Check Pilot Standardization Course Expiration.
